ADVANCED BLOODSTAIN PATTERN ANALYSIS

COURSE DESCRIPTION:

This 40-hour course will provide a basic understanding of bloodstain pattern analysis and the fundamentals of bloodstain pattern interpretation. The basic course syllabus is on file with the IABPA and with the IAI and meets requirements for certification with the IAI.

Craig Moore has 16 years experience with the Forensic Services Unit of the Niagara Regional Police Service, where he has worked since 1984. He became a certified Bloodstain Pattern Examiner with the International Association for Identification in 2000.

Craig Moore is the author of several articles on the topic and has been published in peer reviewed internationally distributed journals, and an undergraduate forensic textbook. His work also includes a homicide case study that was published in an internationally recognized text relating to the use of a computer analytical program. He has presented over 100 lectures on the topic of forensics, including one-week BPA courses (as assistant instructor) at the Ontario Police College, Aylmer and the RCMP's Canadian Police College in Ottawa and he has assisted Mr. Herbert MacDonell for the past four years in his basic BPA course in Corning, New York. Mr. MacDonell is considered by many to be the "father of modern day bloodstain pattern analysis."

Mr. Moore has testified and been accepted as an expert in Bloodstain Pattern Analysis at the General Division and Superior Court of Justice jurisdictional levels in Ontario and at the County Court level in New York State. Recently he was called before a Board of Inquiry with the Canadian Armed Forces to offer expert opinion on a Blood Stain related shooting case.

He is credited with creating a theoretical model of a blood drop in flight, of which design patents are held in the United States and Canada, where this model has been utilized by various agencies including the RCMP, FBI, and NCIS.

He currently sits on the BPA certification board of the IAI and in 2006 was recognized as a Distinguished Member.

Remarks regarding Craig's previous courses revolve around his interaction with the attendees, his crime scene experience, depth of knowledge and uniquely crafted educational aids, where this combination makes for a memorable educational experience.
